Grant Program Description:

This competitive grant program provides support for the development and public presentation of visual art exhibitions by District resident curators. The program does this through grant support and use of CAH's exhibition spaces. Exhibition space is both within the building lobby 200 I (Eye) Street Galleries and on CAH's virtual platform. The FY25 AEG program will request proposals on three specific themes: 1) Social Justice, 2) Veteran Arts, and 3) LGBTQ+ Identity in Celebration of World Pride 2025 DC.

It is then loaned to District Government agencies for display in public areas and offices of government buildings.

Thriving Families is an exhibition in honor of Child Abuse Prevention Month in partnership with Child and Family Services Agency (CFSA). CFSA and its partners hosted community art making events and collected art from area artists from the ages of 4 and up. The resulting works showcase their impressions on what thriving means.

A Toast To The Boogie: Art in the Name of Funk(adelic) (Monday, June 17, 2024 – Friday, August 16, 2024) This upcoming exhibition, *A Toast to the Boogie: Art in the Name of Funk(adelic)* will present never before seen archival works and memorabilia from the family's private collection of musician George Clinton alongside original artworks by DC metropolitan artists. It significantly builds on *The Cosmic Slop Experience*, an exhibition originally mounted at the Eaton Workshop in Winter 2023 celebrating the 50th anniversary of Funkadelic's 1973 album Cosmic Slop.

Endangered Animals Art Project

Dedication Date: Saturday, April 27, 2024

Description: The *Endangered Animals Art Project* is a community-focused public art project that promotes livability, walkability, and delight, as well as awareness of the local effects of our changing environment. The project is an expansion of the successful Capitol Hill Alphabet Animal Art Project (which currently includes 20 sculptures), and 10 new sculptures were installed on the Connecticut Avenue Corridor between the Woodley Park and Cleveland Park metro stations.
