(e.g. if you're planning an abstract art exhibit, provide work samples from previous similar projects.)

Hi Ayo, this is Benjamen. Yes. There's no need to insure more than the event itself. (The asterisk here is that if you've got load-in or strike before or after the event, you'll want to make sure those days are covered as well.)



### John Devlin

Two questions regarding the LiftOff grant program! 1) as this is a capacity-building grant, we hope to use the funds towards a salary for a part-time administrative position. However, the guidelines state that the grant still subject to the 35% administrative cap. Is this indeed the case? 2) the guideline states that liftoff funds cannot support projects covered by other grants. If this funds an admin position, that person will likely be working to help implement programming related to already-awarded grants. Any advice? Thank you for taking the time to help us today!

This is Khalid. Question from John Devlin. This is a capacity building program with a peer learning component. If that person is a part of your capacity building resource - it will not count. This is not a project grant. If the admin person is funded by another grant - it would be considered double dipping - did I understand your second part of the question correctly.

Please address (expand upon) this requirement included in the PEF eligibility requirements for organizations: "Have a commitment to provide arts, humanities and education programs to the residents of Washington, DC..." It appears to limit eligibility to organizations that have the arts, humanities and/or education as a focus.

Question about PEF proposals: We have a PEF proposal that was rejected in the spring, perhaps in part or full because we included an activity—painting a street mural—that we didn't realize was prohibited. When we didn't get all the funds we needed, we divided the project into two phases and completed phase 1 during FY17 with very strong results. Can we submit phase 2 of the project to PEF (omitting the mural, of course) for the Oct. 20 deadline?

Hi Christine. This is Regan. Please take a look at the project eligibility requirements in the FY18 PEF Cycle 2 guidelines. Again, public art programming is not included nor may projects that have already been presented to an FY18 panel. Project applications for Cycle 2 must be new or expanded.

Hi Ayo - yes, all expenses related to the project and project activities must occur by September 30, 2018,

#### John Devlin

Hi Khalid- that sounds good! Our specific situation is that we already received a PEF grant for this year. So we want to make sure that if we receive a liftoff spot, and use those funds to pay a part time admin (who would be the representative in the program), that the person would still be able to implement our PEF programming. And, our plan would be for 100% of the liftoff funds (we would be 15k max) would be paid to that person. But in the guidelines, it still states that only 35% can be used towards any admin personnel costs. And I just want to make sure that is not the case for this specific program



# **CAH Grants Team (Khalid Randolph)**

Hi John, your answer appears you are trying to leverage LiftOff to support PEF - which would not be allowed. The liftoff grant is to support a vision the organization has over the next 3 years - and the resources aligned to that vision. Hi Regan, to follow up on my PEF question, so we'd need to show we've expanded on our rejected proposal from last spring in order to be considered? But if we can make that case we can apply and not be disqualified?

Yes, a project would have to be new or expanded. When you begin the application you must acknowledge that the project has not come before a CAH panel in FY18.

Hi Benjamin - Somehow, my question merged with Alumni from DC Black Repertory. We are not affiliated. Just to be clear, does your answer refer to my question about the PEF eligibility requirement concerning organizational focus on arts, humanities and/or education? We are a faith based organization.

Hi Ayo, so weird! It does, indeed. As long as your 501(c)3 meets the other eligibility criteria (be at least one year old, based in DC, etc.)

Hi DCCAH team! Recognizing you may not have an answer at this time ... but do you know if the Liftoff program will be offered again in future years, like Upstart, or is this more likely to be a one-time opportunity?

Also, does the match requirement for organizations need to be on hand at the time of application or at the time of award, if selected? (Re: PEF)

Ayo - you do not need to have the cash in hand at the time of the application, but it would strengthen your application to have "irons in the fire" where other funding support is concerned. If you can provide a list of possible funders/sources of earned and contributed income, that would be super! Best, David

Any application proposing a project, event, or festival for children or youth will be deemed ineligible. Our event is a family festival that is open to and provides age-appropriate arts and education activities for children as a part of the programming.
