Grant Program Name:

FY24 Art Bank Program (ABP)

Grant Program Description:

In support of local visual artists and art nonprofit organizations, CAH acquires fine art. The ongoing and annual acquisition of art from metropolitan artists becomes a part of the Art Bank Collection. Artwork in the collection is managed by the Public Art Department of CAH and loaned to District government agencies for display in public areas and offices of government buildings. The Art Bank Collection, which started in 1986, has nearly 3,000 artworks in various media.

For the purpose of this grant, metropolitan artist is defined as a legal resident of Washington, DC, or a legal resident of within a 50-mile radius of the Washington, DC boundaries, for at least one (1) year prior to the application deadline. Award amounts to metropolitan artists vary but eligible applicants can be awarded up to \$15,000 for individuals and up to \$20,000 for nonprofit art galleries or organizations.

Program Goals include:

- Growing the District's collection of art to reflect the rich, diverse artistic history and communities of the District of Columbia and metropolitan region.
- Providing support, exposure and professional benefit for visual artists residing in the District of Columbia and metropolitan region.
- Enhancing the aesthetic experience for District employees and visitors that access the District of Columbia government buildings and public spaces.

Ranking and Award Justification:

- **Cut-off:** All eligible applications were reviewed and scored by panelists, in an online review of portfolios, on a scale of 1-10.
 - Panelists recommended 92 finalists and 112 select works for in person finalist round review, with a standard cut off of 7.5.
 - o In the second round of in person review, all 92 finalists work were reviewed. Panelists recommended 88 works by 76 artists.

Allocation of Funds:

- Funding is available to support the recommendation of 76 artists' works, and the total acquisition of 88 artworks.
- Artists are funded in full based on the applicant's request up to the maximum allowable amount by cohort. (Individuals up to \$15,000; Organizations up to \$20,000).
- Total recommended request: \$347,060.00

Outreach and Observations:

- Among the 76 recommended artists, there are 10 (ten) first time applicants, and 39 artists who are new to the Art Bank Collection
- Among the 235 applicants, 67 were first time applicants.
- There was a 8% increase in completed applications between FY23 and FY24.
- We saw a marked increase in applicants from Ward 7 and Ward 8
 - Ward 7 FY24 applications: 19 submitted, an increase of 211% from FY23's 9 submitted applications.
 - Ward 8 FY24 applications: 10 submitted, an increase of 333% from FY23's 3 submitted applications.
- Additional focus was added to RFA and Panel scoring to highlight the Artist's contribution to
 the arts in DC. Applicants were required to provide a new Impact Statement giving artists an
 opportunity to further detail how their career and work commits to the growth of the arts in
 Washington, DC.
- MD/VA FY24 Finalist for recommendation of funding decreased 70% from FY23.
- Outreach efforts were increased by the following:
 - Created an informational one-page flyer that was distributed and emailed to local nonprofit organizations, Business Improvement District (BID), and Mainstreet
 Organizations to reshare and post on community boards.
 - Sent personal emails to over 300 individual DC artists and artists groups to apply with a focus on Wards 7 and 8 (including reaching Wards 7 Arts Collaborative; Black Artists of DC; Congress Heights Arts & Culture Center, and Anacostia Arts Center).
 - Additional one-on-one meetings and calls with prospective applicants to assist with technical issues and answering questions.
 - Facilitated 3 FY24 Art Bank Program Grant Workshops with a total of 77 attendees.
 - May 10 (38 attendees)
 - May 22 (22 attendees)
 - June 9 (17attendees)

FY24 Juried Exhibition Grant (JEG)

Grant Program Description:

2024 Juried Exhibition Grant (JEG). JEG provides support for District-based artists to exhibit their work in a juried, themed visual art exhibition through grant awards and the use of CAH's exhibition space located in the lobby of 200 I Street, SE. For this cycle, the Request for Applications (RFA) sought works for an exhibition that will reflect on legacy and impact of the Civil Rights Act of 1964 during its 60th year anniversary in 2024. This landmark legislation aimed to prohibit discrimination based on race, color, religion, sex, or national origin. By exploring this significant milestone, the exhibition seeks to provide insight into the progress, challenges, and ongoing efforts towards achieving equity and social justice.

Allocated Budget Amount:

FY2024 \$ 28,000

Number of Panels: 1 Juried Panel

Ranking and Award Justification:

- Cut-off: All eligible applications were reviewed. Finalist scores were ranked between 64 and 87.5.
 - The jurors reviewed top scoring artworks and recommended 28 artists for funding.
 - Recommend funding for 28 individual artists representing 53 artworks.
 - Per the RFA, each artist would receive a grant of \$1,000, regardless of the number of works accepted into the exhibition.
- **Exhibition Breakdown:** Based on the finalists works around the broad topic of Legacy and Impact of the 60th Anniversary of the Civil Rights Act of 1964, the jury and CAH staff narrowed down the theme to the following unifying topics to present a cohesive exhibition:
 - Individual Action
 - People of the Movement
 - DC as a culture and place of political action
 - Impact of material culture
- Allocation of Funds:
 - Funding is available to support the recommended 28 artists at \$1,000 each.

Total Recommended request: \$28,000

Outreach and Observations:

- Two virtual workshops were held.
 - o Friday June 30th
 - Monday July 17th
- The Deadline was extended.
- There was direct effort to reach artists in DC outside of CAH's regular mailing list. The RFA was sent to local artists groups like Black Artists of DC, all Communications staff members for the Council of the District of Columbia, specially designed social media campaign posted on CAH's Instagram page.
- All 8 Wards were represented in the application pool and there are artists from each ward among the finalist recommendation.
