Greetings Executive Committee!

The aim of this work is to enhance the flow of communication among Commissioners, between Commissioners and staff, and in Commission-to-public via our monthly meetings. Governance Committee charge Section 5. Governance Committee:

The Committee shall draft amendments or revisions to the <u>By-laws</u> to guide the operations of the Board based on the principles of inclusion, diversity, equity, and access.

- **August 19** Full Commission Meeting, Governance Committee presents quarterly report including revised by-laws for full board discussion and vote. <u>CAH staff assistance required</u>

- Section 4. The Secretary. Monthly and quarterly Committee Reports are sent appropriate staff and Secretary at least four days prior to meeting.
- Article VII Administration. Section 1. The Executive Director. Executive Director to report monthly on the Strategic Plan and 44 Task Force Recommendations.
- No mention of our policy to read the land acknowledgement or each commissioner self-descriptions at public meetings.
- Nothing outlined for communication to Commissioners on cancelations and or rescheduling of monthly meetings.
- Nothing outlined for Committee Chairs setting and notifying members and staff of monthly meeting schedule.
- Revision outlined in the 21-24 Strategic Plan Reduce the number of Commission meetings from monthly to bi-monthly or fewer.

Specific Committee function or method

Current By Laws:

- Section 11. Other Committees, including, Ad Hoc Committees, standing, special, or advisory, may be appointed via written Resolution by the Chairperson with Board approval as deemed necessary.
- Section 5. Governance Committee Under the leadership of the Chairperson, the Committee shall conduct an annual review and performance evaluation of the Executive Director.
 - 21-24 Strategic Plan outlines:
 - d. Agency staff report to the Executive Director, who is responsible and accountable for managing all day-to-day operations and performance of the agency, including its staff and budget, including the implementation of this Plan; as the Executive Director's supervisor, the CAH Chair will evaluate the performance of the Executive Director annually.
- Per the 21 24 Strategic Plan e. A Governance and Nominating Committee should be formed to facilitate communication among Commissioners on governance matters.

i. Commissioner appointments should be based on the current mix of Commissioner skills and an assessment of the attributes and skills desirable in new Commissioners, balancing the need for experienced Commissioners with the need to add new energies and skills to the Commission, as well as a balance between representatives of large and small organizations and diverse individual artists.

ii. Based on Governance Committee input, the CAH Chair will confer with the Mayor's Office of Talent and Appointments regarding appointments to the Commission.

- "b. The Executive Director reports to the Commission in the person of its Chair."

Edit/Update Proposal

⇒ Add clarifying language to by laws under Section 2 The Chairperson and Section 1 The Executive Director to clarify reporting and press/public comment eg any SOPs required.

By Law Triennial Review

• Per our by-laws 'Article IX Amendment': "These Bylaws may be amended at any regular or any special meetings of the Board, by a two-thirds vote, provided that the amendment has been submitted in writing two (2) weeks prior to the meeting."

Edit/Update Proposal

 \Rightarrow Discussion on outlining triennial review of full by laws not just amendments here and there to further guide the operations of the Board based on the principles of inclusion, diversity, equity and access.

Art and Humanities Sponsorship this section requires committee action

Current By-Laws:

- Section 3. Executive Committee (ExComm) "The Committee shall have the authority to approve expenditures of no more than \$3500.00 for arts or humanities purposes"
- or
- Section 2. The Chairperson 7. "Commit the Agency with the appropriate funding mechanisms to partnerships, new programs and other new CAH endeavors, after consultation with the Executive Director, and with a majority vote of the Board. These commitments shall not conflict with the contracting authority of DC Office of Contracting and Procurement (OCP)."

Are either of these referring to sponsorship of arts or humanities events etc.? If not where should be or is the approval process for partnerships of Art and Humanities partnerships reside.
