FY 2020 Funding

The grant period is from October 1, 2019 to September 30, 2020. Grant funds may not be used for activities or expenses that occur outside of the grant period.

Funding Requests

Organizations may apply for up to \$20,000 (Maximum Award). Only one (1) Arts/Humanities Education Project grant application may be submitted per grant cycle.

Applicants should read through these guidelines in their entirety prior to submitting an application.

As the designated state arts agency for the District, CAH is an agency of the Planning and Economic Development Cluster of the Executive Branch of the District government, and is supported primarily through District government funds and in part by the National Endowment for the Arts.

ARTS/HUMANITIES EDUCATION PROJECT (AHEP) PROJECT-BASED GRANT

AHEP Program Overview

CAH seeks grant applications from qualified arts, humanities and arts education organizations and program providers to deliver exemplary programs in arts and/or humanities education to students in grades pre-K to 12 and to teachers, educational staff and teaching artists of DCPS and DCPCS schools. CAH will award select applicants ("grantees") a grant of funds to support the delivery of their proposed program. Grants funds are applicable only to CAH's Fiscal Year 2020 ("FY 2020"), which occurs from October 1, 2019 to September 30, 2020, and which is referred to as the "Grant Period" in this document.

Grant award funds cover expenses made only within CAH's Grant Period.

Grants are competitive and applications will be organized for review in cohorts based on the following qualifying project categories: (1) In-School Project, (2) Out-of-School-Time Project, or (3) Professional Development Project.

By making its AHEP grant awards, CAH endeavors to meet the following goals, and an applicant's submission should offer consideration to these goals:

- Provide access to high-quality arts and humanities experiences that work to advance student academic achievement in the District of Columbia;
- Strengthen the value of arts and humanities education as a critical component of a student's broader education; and
- Support activities that are consistent with local and national learning standards for arts and humanities education, including the current state standards in non-arts content areas where appropriate.

Cash-Match Requirement

The AHEP grant has a 1:1 cash-match requirement designed to leverage funding from additional private funding sources. In-kind contributions, CAH or other District Government funds may not be used to satisfy the match requirement of this grant by grantees.

Description of AHEP Grant Project Types

The AHEP grant program provides support for the following types of projects:

- In-School Projects are defined as those that take place within the traditional school day and may include artist residencies, field trips and arts integration opportunities. Projects must connect to curricula standards and instructional programs occurring in the schools. Assessment and evaluation criteria should emphasize an intentional and comprehensive design.
- Out-of-School-Time Projects are defined as those that take place in the after-school, weekend and/or summer hours. They may take place on school premises, but are often facilitated by non-school arts and/or humanities providers. Priority is given to projects that engage participants multiple times throughout the year.
- Professional Development Projects include high-quality training opportunities for educators that enhance their skills in an arts discipline or in the integration of standards-based arts and/or humanities instruction with non-arts academic content. The project must target classroom educators, instructional staff or teaching artists providing services at a DC public or public charter school. Teaching artists must reside in the District of Columbia.

Public Charter Schools and Parent Teacher Associations are eligible to apply, but funding may not be attributed to school personnel, faculty and/or general art supplies or equipment. The AHEP grant will not offset the responsibilities of each school in providing its students with an excellent education, but will support projects that enhance the learning that is already in place.

Successful AHEP Applications

- Provide a brief overview of the organization's general programming, but articulate the details of a unique project that is the focus of the project-grant application;
- Demonstrate expertise in offering developmentally appropriate arts and/or humanities programming for students with evidence of reasonable accommodations for working with students of diverse abilities;
- Articulate an understanding of curriculum design through the provision of syllabi, lesson plans and assessment tools;
- Develop and detail programming that provides an immersive experience for participants;
- Provide evidence of an intentional and comprehensive assessment and evaluation plan;
- Demonstrate that the majority of the project activities occur within the District of Columbia;

- Demonstrate experience in offering high-quality, impactful professional development for educators in order to enhance their skills in an arts discipline or in the integration of standards-based arts and humanities instruction with non-arts academic content; and
- Have an active board of directors.

Eligibility Requirements

Prior to submitting applications, applicants must meet all of the following eligibility requirements:

- Be incorporated as a nonprofit with a federally-designated tax exempt status under section 501(c)(3) of the United States Internal Revenue Service (IRS) code, as evidenced by an IRS determination letter that is dated at least one year prior to the application deadline date;
- Be registered with, and authorized to do business in, the District as either a "Domestic" entity (that is, an entity that was incorporated in the District) or a "Foreign" entity (that is, an entity that was incorporated in another state);
- Ensure that at least fifty-one percent (51%) of the organization's activities occur within the District of Columbia;
- Ensure that one hundred percent (100%) of the grant award dollars are used to support District of Columbia personnel and programming;
- Have an active Board of Directors;
- Register and comply with the regulatory requirements of the following agencies:
 - District of Columbia Department of Consumer and Regulatory Affairs' (DCRA) Corporations Division (indicating an "active" business license status at the time of application, and agreeing to maintain such status throughout the grant period);
 - 2.) District of Columbia Office of the Chief Financial Officer, Office of Tax and Revenue (OTR);
 - 3.) District of Columbia Department of Employment Services (DOES); and
 - 4.) United States Internal Revenue Service (IRS);
- Obtain certification of "Citywide Clean Hands" (CCH) from the District of Columbia Office of Tax and Revenue (see page 12);
- Be in "good standing" with CAH. Note: a CAH grant applicant that has failed, as of May 3, 2019, to comply with all applicable CAH-related mandates (e.g., failed to submit to CAH required reports related to prior CAH funding), is not in "good standing" with CAH and, accordingly, is ineligible to receive additional funds from CAH in FY 2020); and
- Have a principal business office address that is located in the District of Columbia, subject to on-site visit. (Note: CAH will not allow post office boxes or the addresses of board members or volunteers as evidence of the principal business address).

Applicants restricted from applying include:

- Individuals;
- Arts and humanities organizations with a majority of their constituents who reside outside of the District of Columbia;
- Arts and humanities service organizations who provide specialized services which can include professional development, technical assistance, networking opportunities, shared operational services, printed materials and/or research;
- Private clubs and organizations that prohibit membership based upon race, gender, color, religion, or any other classes identified in the District of Columbia Human Rights Act;
- Individuals; organizations that require "fiscal agents"; for-profit organizations; private foundations; political organizations; colleges; universities; foreign governments; federal government entities; and other District of Columbia government agencies, including DC Public Schools and charter schools;
- Recipients (or intended recipients), of a CAH FY 2020 General Operating Support (GOS) grant; and
- Organizations submitting an application whose content is combined with the application of another organization. Proposed projects must be "stand-alone" projects.

Allowable Costs and Funding Restrictions

Organizations that have received an "intent to fund" notification for FY20 General Operating Support (GOS) are restricted from applying to FY20 Arts/Humanities Education Projects (AHEP) and Projects Events or Festivals (PEF). Organizations residing in Wards 7 or 8 that have received an "intent to fund" notification through GOS may apply to the East of the River (EOR) Grant.

The Council of the District of Columbia ("Council") may decide, during the District's annual budget process, to identify one or more arts and humanities organizations that will receive a "Budget Enhancement Grant." If an organization receives CAH funding through one of the above-referenced CAH grant programs ("CAH Grant Award Funds") and the Council awards to that same organization an additional Budget Enhancement Grant, that organization will be required to return to CAH all of the CAH Grant Award Funds that were issued to it as part of CAH's project-based or capacity building grants.



As an agency of the Government of the District of Columbia, CAH ensures that its grantmaking funds are expended in a fiscally responsible manner. CAH grant-related "allowable costs" are those that the District Government and CAH have determined as valid expenditures. All awarded funds are subject to audit and Performance Monitoring (see page 13 below).

Examples of "Allowable Costs" Related to the Grant:

- Salaries for arts and humanities educators for nonprofit organizations;
- Teaching artists/humanists, or consultants;
- Travel and transportation directly related to project implementation;
- Materials, supplies and equipment purchases no more than 25% of the award that are directly related to project implementation; and
- Overhead, maintenance and administration not exceeding 35% of the grant and match, as long as the entity is not a Public Charter School or Parent Teacher Association.

Examples of "Unallowable Costs" Related to the Grant:

- Overhead, maintenance and administration exceeding thirty-five percent (35%) of the grant and cash-match;
- Food and beverages;
- Operational reserves;
- Tuition and scholarships;
- Debt reduction;
- Re-granting (also known as "sub-granting");
- Costs related to fundraisers and special events;
- Equipment expenses that exceed twenty-five percent (25%) of the grant award;
- Expenses unrelated to the execution of the project; and
- Funding to universities, foreign governments or DC government agencies, including DCPS.

The AHEP grant program manager reviews and approves all expenses before the grant agreement is processed for payment. Grantees with questions regarding allowable costs may contact CAH's grant program manager. The grantee will be responsible for demonstrating expenses, as applicable, in Interim and Final Reports. This AHEP grant period is from October 1, 2019 to September 30, 2020. CAH mandates that all of a grantee's grant-funded activity expenses must be made during the District's Fiscal Year 2020 (that is, from October 1, 2019 until the end of the day on September 30, 2020). Specific projects/programs underwritten by the grant must be completed by August 15, 2020.

Inclusion, Diversity, Equity, Access

In addition to detailed plans for its compliance with the Americans with Disabilities Act (ADA) (42 U.S.C. §§ 12101 et seq.), each applicant must demonstrate how the project will be inclusive, diverse, equitable and accessible throughout the District of Columbia, beyond participants with disabilities. Successful applications will consider a broad definition of "accessibility" by addressing financial, geographic, demographic, cultural and developmental access. Notwithstanding the fact that it has shared hyperlinks attached immediately above and later below, the District government does not represent that shared text of the ADA (or any other text) is the latest version of the subject law.

Technical Assistance and Workshops

CAH staff members are available to assist grant applicants through group or individual technical assistance. CAH staff members will not write applications for applicants. CAH staff members are available to review draft applications for thirty (30) minute appointments, on government business days up to one (1) week prior to the grant application deadline. Applicants should contact CAH to schedule a meeting by calling 202-724-5613. Please note that CAH requests the applicant prepare and deliver (by email or via the online grants portal) their full draft application proposal along with any questions in advance of scheduling a meeting for agency staff assistance.

CAH conducts free workshops for participants to learn useful information about the agency's funding opportunities and how to submit a grant application. Workshop dates, times and locations listed below are subject to change. All workshops are free and open to the public; however, participants are strongly encouraged to RSVP. Photo identification is required to enter CAH offices. Grant Application Process

- 1. Read the <u>FY 2020 Guide to Grants</u>
- 2. Read the Request for Applications (RFA) guidelines for the desired grant program and determine eligibility
- 3. Go to <u>Apply for Grants</u> on CAH's website and select <u>Grant Application Portal</u> to register as a user (Note: to reset a user password either select "Forgot your password?" or click <u>here</u>).
- 4. After registration, applicants select the desired grant program(s)
- 5. Complete the questions in the online application
- 6. Upload required documents, supplementary material and work samples
- 7. Double-check the application for thoroughness, clarity and typographical errors
- 8. Submit the application by 4:00 pm ET on the grant program's deadline date

9. Ensure receipt of grant submission confirmation email (auto-generated by the online portal) by the application deadline

CAH utilizes an online grant portal to receive grant applications. <u>All applications must be</u> <u>submitted online by 4:00 pm ET, Friday, May 31, 2019</u>. A confirmation email generates automatically upon submission of the application. Technical issues or failure to receive a confirmation email should be immediately brought to the attention of CAH staff. Incomplete or late applications or applications that do not follow the instructions and guidelines are deemed ineligible for review and funding. CAH does not accept mailed, emailed or hand-delivered copies of grant applications and/or the required attachments. CAH will accept reasonable accommodation requests from applicants with disabilities to submit grant applications via mail, email or hand-delivery. To request a reasonable accommodation, contact David Markey at 202-724-5613 or <u>david.markey@dc.gov</u> and await request approval.

CAH's grant application process is competitive and subject to the availability of funds. Applicants may not request or receive funding for the same activities through more than one CAH program or grant category. Multiple applicants may not apply for funding for the same scope of work, whether through the same or different grant programs.

Applicants are fully responsible for the content of their application materials. An automated confirmation of an applicant's submission does not guarantee an applicant's eligibility, and therefore review by the advisory review panel (see below, "Review Process"). CAH staff is not required to make corrections to applications on behalf of applicants. CAH staff reviews applications for eligibility and completeness and contacts applicants for any missing or incomplete mandatory documents. Applicants are responsible for returning any additionally documents to CAH staff within three (3) business days of CAH's notification. Failure to do so will disqualify the application.

✓ REMINDER: The grant period is from October 1, 2019 to September 30, 2020. Grant funds may not be used for activities that occur outside of this grant period. Specific projects/programs underwritten by the grant must be completed by August 15, 2020.

Application Review Process

CAH selects individuals who are arts, humanities and/or business professionals, independent of CAH, to serve as advisory review panelists for each grant program. The role of a panelist is to review and score an eligible application's content to the established grant program review criteria. Panelists participate in a group review of CAH grant applications, according to their cohort, to discuss and comment on the merits and deficiencies of applications and finalize their application-related scores in the presence of CAH staff and Commissioner Conveners.

CAH staff, Commissioner Conveners and panelists are to remain impartial in their review of CAH grant applications. CAH ensures that all involved recuse themselves from review of any application that presents a personal or professional conflict of interest (or the appearance of a conflict of interest).

CAH's grant application evaluation process takes into consideration general standards of decency and respect for the diverse beliefs and values consistent with <u>The National Foundation</u> on the Arts and Humanities Act, as amended in 1990. Notification and Payment of Grant Awards

CAH will notify applicants of this grant program as to the results of their application by Monday, October 1, 2019 via (1) letter of conditional grant award, (2) letter of ineligibility or (3) letter of denial.

For award recipients, the date of CAH grant award payment disbursement(s) is subject to the availability of funds and the processing of required documentation. CAH staff will advise grant award recipients on the payment disbursement process on or after October 1, 2019. CAH does not disburse grant award payments through its office. However, in collaboration with other District of Columbia government agencies, and in a timely manner, CAH processes the grant award payment requests for grantees. To expedite grant award payments, CAH advises grantees to register to receive a direct deposit for the grant award, by completing an Automated Clearing House (ACH) Vendor Payment Enrollment Form. The ACH Form may be found on CAH's website at Managing Grant Awards. CAH also advises grantees to register in the electronic invoicing DC Vendor Portal system through which payments are processed.

Conditions of Funding, Reporting Requirements and Grant Rescindment

CAH reserves the right to rescind any and all grant awards for non-compliance with CAH's RFA guidelines, policies or regulations, at any time. FY 2020 grantees with unmet reporting obligations regarding any CAH funding program by close of business on Friday, October 16, 2019 are ineligible to receive additional awards from CAH.

Reporting Requirements

Each grantee will be required to submit to CAH Interim and Final Reports regarding: (1) the extent to which they met their CAH grant award-related organizational and project goals; and (2) the quality of the engagement and responsibility to the community that its funded projects or activities have had on the District of Columbia.

Each grantee's respective report must also include:

- Financial reporting regarding the funded activity that clearly shows how the subject grant funds were used;
- Proof of expenditures and related locations data;
- Numbers of people and communities served;
- Number of schools served (if applicable); and
- Numbers of local artists and youth engaged.

Grantees awarded \$10,000 or less must submit a Final Report by Friday, October 16, 2020. Grantees awarded between \$10,000 and \$200,000 must submit an Interim Report by Friday, April 17, 2020 and a Final Report by Friday, October 16, 2020. Grantees with delinquent reports will not be eligible to receive subsequent payments or awards in current or future grant cycles.

All of the above-referenced reports must be completed and submitted to CAH through its online portal. Grantees may access the Interim and Final Report forms through the <u>Managing</u> <u>Grant Awards</u> page on CAH's website.

Grant Management and Rescindment

Grantee agrees that it will include a CAH logo and a credit line in all of its grant-related announcements and promotional materials and that it will make its best efforts to publicly credit CAH's support for the project in all related public events.

CAH has the right to withhold, reduce or rescind a grant award according to the terms and provisions of the grant agreement or if the grantee exercises any of the following:

- Fails to meet deadlines for grant reports;
- Fails to notify CAH of changes in project collaborators or other significant management changes or changes in the project scope without advance approval;
- Refuses to provide access for monitoring;
- Fails to comply with the terms of the grant award contract requirements;
- Fails to demonstrate adequate financial management and oversight of the project; and/or,
- Fails to properly publicly credit CAH's support of the funded project.

Citywide Clean Hands (CCH)

All applicants that are recommended for funding must obtain from the District of Columbia a "Citywide Clean Hands Certification", in order to receive a grant award from CAH. This certification is required before any related grant disbursement may be made. The CCH website application supports the "Clean Hands" Mandate (D. C. Code § 47-2862) which stipulates that individuals and businesses are to be denied District goods or services if there is a debt owed to the District of Columbia of more than one hundred dollars (\$100.00) for fees, fines, taxes or penalties. Legal Compliance

Federal and District of Columbia law requires all grant applicants to comply with all applicable laws and regulations that regard non-discrimination. The list of those laws and regulations include:

- Title VI of the Civil Rights Act of 1964 (which provides that grantees must take adequate steps to ensure that people with limited English proficiency receive the language assistance necessary to afford them meaningful access to grant-related programs, activities and services);
- Title VII of the Civil Rights Act of 1964 (P.L. 88-352) (which prohibits discrimination on the basis of race, color, or national origin);
- Title IX of the Education Amendments of 1972, as amended (20 U.S.C. Sections 1681-1686) (which prohibits discrimination on the basis of sex);
- Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. Section 794);
- The DC Human Rights Act of 1977; and
- The Americans with Disabilities Act of 1990 (42 U.S.C. §§12101 12213) (which prohibits discrimination on the basis of disabilities).

Americans with Disabilities Act

CAH is committed to ensuring that all grant recipients comply with the Americans with Disabilities Act (ADA) of 1990. The ADA provides civil rights protection to individuals with disabilities in the areas of employment, services rendered by state and local government, places of public accommodation, transportation and telecommunication services. Organizations funded by CAH must make reasonable accommodations to ensure that people with disabilities have equal physical and communications access, as defined by federal law.

An organizations applying for funding from CAH must include, in its grant application, a response to the information request set forth in the "Accessibility" section of its grant application, by providing the following information:

- 1. The process for formulating accessibility plans (e.g. creating an accessibility advisory committee, board and staff disability-rights training, budgeting for reasonable accommodation requests, etc.).
- 2. The current progress/status of an organization's physical accessibility. If the location is not barrier-free, include in the grant application a plan for project/program modification that ensures access in a barrier-free environment, when needed.
- 3. The current progress/status of the organization's accessibility in presenting activities communications access (e.g. TDD, large print or Braille materials, audio description or assistive listening devices, interpreted performances, etc.) and marketing/advertising.

Risk Management and Performance Monitoring

All grantees are subject to risk assessments and monitoring requirements, as outlined in the District's <u>Citywide Grants Manual and Sourcebook</u> (which is primarily managed by the District's Office of Partnerships and Grant Services (OPGS)). CAH has established standards for grantees to ensure compliance with risk assessment monitoring, and those standards are discussed in greater detail in the applicants' grant agreements with CAH.

Activities funded by CAH will be monitored and evaluated by its staff, to assure compliance with all applicable District of Columbia's statutes, regulations, orders and other requirements. This monitoring process may include site visits, an evaluation of allowable costs, as assessment of efforts to meet projected grant applicant benchmarks, providing proof of expenditures, etc.

All grantees are responsible for reporting their respective grant award(s) as income on federal and local tax returns (in accordance with applicable law) and are strongly encouraged to consult with a tax professional and the United States Internal Revenue Service.

ARTS/HUMANITIES EDUCATION PROJECT (AHEP) APPLICATION REVIEW CRITERIA

Arts, Humanities and Arts Education Content and/or Merit 40%

- The applicant's work sample(s) and educational material(s) (syllabi, lesson plans, rubrics, etc.) demonstrate high standards of artistic, humanities and educational excellence within the chosen discipline(s);
- The project activities demonstrate advancement in student learning through arts and/or humanities related experiences;
- The project's goals/activities are attainable and appropriate to the grade level intended; and
- The applicant demonstrates the use of personnel with subject matter expertise (such as arts administrators, teaching artists, educators) to plan and implement content.

District Engagement and Responsibility to Community 30%

- The project demonstrates the ability to reach a substantial population of DCPS and DCPCS students;
- The project activities serve to enrich the educational experience of the intended students;
- The project activities reasonably accommodate persons with disabilities;
- The applicant presents effective evaluation methods specific to the project with the desired outcome of improving future activities and services;
- The project activities provide meaningful engagement with communities of students and/or educators; and
- The applicant articulates how services or the project's deliverables will promote inclusion, diversity, equity and access for participants, staff, board and the broader community.

Organizational Management, Capacity and Sustainability 30%

- The applicant demonstrates skillful project management, organization and deliverability;
- The applicant demonstrates proficient curriculum development and execution, and knowledge of educational standards to achieve successful project implementation;
- The applicant demonstrates appropriate financial monitoring systems to track expenditures;
- The applicant's budget information is detailed, accurate, feasible and directly related to the activities of the grant request; and
- The applicant demonstrates the ability to attract financial support necessary to complete the activities and to meet the 1:1 cash-match requirement of this grant program.

ARTS/HUMANITIES EDUCATION PROJECT (AHEP) APPLICATION CHECKLIST

 - CAH recommends reviewing the Work Sample Addendum to determine what work samples would best represent your project and your organization.
- Support Materials, such as up to three (3) internally-produced items (e.g. curricula, strategic plans, marketing materials, etc.) and up to three (3) externally-produced items (e.g. reviews, commendations, testimonials, letters of support, etc.)
- Résumé of Key Personnel (e.g. artistic/managing/executive directors, arts educators, etc. with roles, responsibilities and home addresses clearly indicated);
- List of current Board of Directors with roles (e.g. president, treasurer, etc.), responsibilities and home addresses indicated;
- Current organizational budget as approved by the organization's Board of Directors;
- Profit and loss statement from most recently completed fiscal quarter;
- Balance sheet from most recently completed fiscal year;
- Most recent IRS Form 990; (for organizations under \$50K bank statements from the past 12 months);

DC Office of Partnerships and Grants (OPGS) compliance documents (Templates and instructions are available at:<u>http://dcarts.dc.gov/page/managing-grant-awards</u>)

- Arrest and Conviction Statement (dated at the time of application submission)
- Certificate of Clean Hands (dated no more than 30 days prior to the deadline)
- Articles of Incorporation
- Certificate of Liability Insurance general liability coverage
- IRS 501(c)(3) Letter of Determination
- Statement of Certification (dated at the time of application submission)
- Signed IRS Form W-9 (Note: Post office boxes are prohibited. Address must match address in grants portal. The October 2018 version of the form must be used and dated at the time of application submission)

Addendum A: Work Samples and Supplementary Materials

The DC Commission on the Arts and Humanities (CAH) values and emphasizes excellence in all grant programs within all disciplines. This section contains detailed information on the CAH's requirements and suggestions regarding content.

Arts and humanities content and/or merit are one of several criteria on which an application is reviewed. Other criteria include: District Engagement and Responsibility to Community, Financial Capacity, Management and Sustainability, and others as dictated within the RFA guidelines. Arts and humanities content and/or merit is demonstrated to the advisory review panelists through the applicant's:

- Section 1 Work Samples
- Section 2 Support Materials
- Section 3 Résumés of Key Personnel
- Section 4 General Suggestions from CAH Staff

Of these, the work sample carries the most weight because it must contain the clearest depiction of the applicant's best work(s) of art and/or humanities. All applicants must submit arts and/or humanities work samples or demonstration of content of services provided to artists and humanities practitioners.

To further assist the applicant in submitting strong artistic content with an application, general suggestions are provided in Section 4 (below).

Section 1 - Work Samples

Work samples are critical to each application and are carefully considered during application review. CAH strongly recommends that applicants pay close attention to the content of work sample submissions.

The guidelines on what to submit within a work sample submission depend on the grant application. Applicants must adhere to the work sample requirements below in order to be eligible for consideration of a grant award.

Work samples must be no more than three (3) years old from the date of submission. Submitting older work samples will render the application ineligible for funding consideration.

	Playbills and programs are prohibited as work samples. However, they may be included as support material.

Sound Designers	Submit up to three (3) audio recordings.

Section 2 - Support Materials

Support materials are documents that strengthen the application and provide additional information that directly relates to the grant request. Support materials do not take the place of a work sample. They do, however, reinforce the quality of the applicant's discipline(s).

Some examples of support materials are:

- Theater/exhibition reviews
- Letters of recommendation
- Certificates
- Sample lesson plans
- Assessments and evaluations
- Awards

Assessment and Evaluations

Purpose:

- To determine the efficacy of a program, as articulated in the program goals and as required for grant reporting.
- To provide evidence to support changes in order to improve the program and its delivery.

Types:

- Qualitative assessment is often subjective in approach and narrative in nature.
- Quantitative assessment provides empirical data that demonstrates growth in the knowledge, skills and understandings of the participants.

Assessment and Evaluation Design

There are many ways to assess and evaluate programming including: needs assessments, preand post-testing, and formative, observational and summative assessments that utilize mixed method approaches such as portfolio assessment.

Section 3 - Résumés of Key Personnel

Another way for the advisory review panelists to determine the artistic content of each application is to review the résumés of the key artists, administrators and facilitators involved in

the grant activities. Those professionals involved in the organization determine the capacity of the organization and ability for the applicant to effectively create an excellent arts and humanities product and/or experience. Their backgrounds as artists and administrators should be relevant to the organization and clearly demonstrated through their professional résumés.

Section 4 - General Suggestions from CAH Staff

When creating and preparing work samples, support materials and résumés, CAH recommends considering the following:

- Applicant should be able to view and/or play all work samples in the application before submitting. If a sample cannot be played, then panelists will experience the same;
- Select recent, high quality samples that relate as directly to the application as possible;
- Photograph uploads should be in JPEG (or JPG) format with a 72 dpi minimum resolution and should not exceed 20MB in size;
- Adding more than the recommended number of work samples to an application will often weaken it;
- Carefully chosen work samples (pictures, videos, excerpts, etc.) tend to make the biggest impact and create the strongest artistic impression;
- Advisory review panelists are required to review each applicant's work samples; however, they are not guaranteed to review multiple work samples within the same application;
- Each work sample and document must be labeled clearly so that panelists can identify what they are reviewing;
- For project-based grants, include samples of similar projects completed to illustrate an ability to execute the proposed project; and,
- Panelists must be able to assess the skill level of the artist(s) involved in the project work to be created, exhibited or taught.

For video submission:

- Do not include highly edited commercial/promotional video as a work sample;
- Do not include poor quality video samples or samples with dim lighting, unstable video, bright backlighting or blurred images; and,
- If the video work sample is longer than five (5) minutes, indicate the embedded timecode of the video where panelists should begin viewing the work sample (e.g. 5:05:00).

For online materials and websites:

- A website is often an insufficient work sample. Submit a website only if it is an essential part of the project;
- Provide all passwords or include any necessary information required to view the work sample, such as plug-ins or navigation paths; and,

• Ensure links to online materials or websites are fully functional and up-to-date. An inoperative link to a website containing a work sample will negatively affect the application. CAH is not responsible for any material obtained outside of its online grants portal.
