

# **GRANTS UPDATE**

### **FY22 Updates**

## Relief and Recovery Fund (Individuals and Organizations)

Two new relief and recovery grants launched on Monday, May 16<sup>th</sup>. Both grants were scheduled to close on June 6<sup>th</sup> but were extended through June 17<sup>th</sup>.

**RRFi:** 343 Applications

• 21% increase on FY21

19.5% new applicants to CAH

**RRFo:** 30 Applications

• 33% new applicants to CAH

66% previous grantees, but not funded in FY22

#### Capacity Building Initiative

Two planning meetings are scheduled for this coming week for the nine (9) organizational leads and eight-one (81) organization members of the communities of practice. Capacity building programming will take place through the summer and wrap up by the end of September.

#### Budget Update/Enhancements

All additional funds have been loaded to the FY22 budget. Enhancement notifications are scheduled to be sent to grantees during the first week of July.

#### Panelist Payments

The Policy and Process document has been vetted by the Legal Dept. and we will begin the gift card distribution process this week.

### Grants Reconciliation Document

The Finance Dept. created an analysis of the grants and payment processes for the current year to date. Grant managers from the Grants and Public Art Depts. added narrative explanations to the document to help identify key internal and external challenges to moving grants forward.
