- Julianne Brienza from Capital Fringe thanked the Commission for the Upstart Grant that that her organization received this past fiscal year that assisted them in launching a new website, capitalfringe.org . She spoke about the upcoming Fringe Festival taking place July 8<sup>th</sup> through the 28<sup>th</sup> that is was the largest festival in three years:
  - 90 productions in eight venues, with 13 stages. This year 70% of the participants are residents of the DMV. And 49% are residents of the District of Columbia.
  - Three new plays by local playwrights. The festival will present Mike Daisey and his performance of A People's History and the lead writer of the Simpson's new play, called Shakespeare's Worst.
  - Launching new book at Politics and Prose on the Wharf.
- Chair Kendall thanked Julianne for presenting and asked the Commissioners and staff present in the room to share one thing arts related with everyone before the meeting began.

## **Chairperson's Report**

- Chair Kendall asked which Commissioners were on the call.
  - Commissioner Osuchukwu
- Chair Kendall discussed:
  - The mission of CAH: To provide grant funds, programs, and educational activities that encourage artistic expressions and learning opportunities so that all the District of Columbia residents and visitors can experience the rich culture of the city.
  - CAH's Annual Report for FY18 (to name a few):
    - 692 grants- 24% increase in the last two years
    - Spent over 23 million dollars in grants awarded- That's a 63% increase in the last two years.
    - Increased commitment to nearly \$2 million for grants that are east of the river.
  - Council BSA changes this week:
    - Tuesday, 6/18, vote on the budget support act included several directives to our agency concerning budget allocations governance structure.
    - Agency's funding is now from dedicated tax, non-lapsing, which will be deposited into the Arts and Humanities Fund.
    - 28% of that will be distributed noncompetitively, but proportionately to each organization that belongs to the National Capitol Arts cohort, in an amount based on that organization's share of the total annual amount for the prior year. Not including District funds.
    - Five percent of the budget is going to go to a Humanities Grants Program.
  - Filling of the Finance Manager Vacancy within CAH completed
  - Governance:
    - Mayor will continue to appoint the Chair from the Commissioners. And will continue to appoint the Commissioners.
    - Commission shall hire an Executive Director by October 1, 2019- Executive Director Rosario has been exemplary in doing her job to the wonderful ability and the very inclusive leadership style, which I wanted to appreciate. And I have nothing but good things to say about Terrie.
- Commissioner Sattrnilasskorn asked what non-compete means for the 28% budget allocation and if that means they can't apply for other grants and how is designating the organizations to receive it.
- Chair Kendall stated that there has been designated 20 organizations that are mostly, mostly the largest budget organizations in the city with the idea that they drive the creative economy in a way that means they want the stability of knowing that they can count on a certain budget support.
- Commissioner Palermo asked if it means that Council is giving CAH money, that they're telling us how to spend and that this is not the usual decision.
- Chair Kendall stated that yes, every year the agency has some funds earmarked and the agency has always administered it. In fact even though the other years it looked like earmarks, some were competitive and some didn't always work out the way they may have been intended to. These will not be competitive.
- Chair Kendall stated that she would send the list of 20 organizations out to the Commissioners.
- Chair Kendall asked for the Executive Director report

### **Executive Director's Report**

- Executive Director Rouse-Rosario discussed:
  - o The new vote by City Council making CAH an independent agency
  - The Mayor's ability to still appoint Commissioner and the Chair of the Board.

- Commissioner Friedman asked if the Events positions would be filled or re-structured.
- Executive Director Rosario stated when FTE's leave, you replace them with other FTE's. The agency has Contractors in place that can assist with any gaps until the positions get filled.
- Commissioner Miller thanked the Events team for their hard work throughout the years.
- Commissioner Ucles asked why officers were present in the lobby.
- Kennisha Rainge stated that routine checks were done by officer's daily in the entire building.
- Commissioner Palermo asked the Executive Director was she going to apply for the Executive Director position?
- Executive Director Rosario stated she was not certain.
- Chair Kendall stated that Executive Director can apply and that a national search would be done.
- Chair Kendall called for Michael Bigley to give overview of the Committee reports.

  - o LiftOff Capacity Building Grant(2<sup>nd</sup> year)- For smaller organizations with budgets up to \$250k
  - UpStart- Organizations with budgets above \$250k- \$1.1 million
- Chair Kendall asked a new public member in the room to introduce himself
- Nabeeh Bilal from Creative JunkFood introduced himself and mentioned that he just did a mural with Candice Taylor on Minnesaota Ave.
- Chair Kendall asked Commissioner Gates to give the Public Art Committee Report

## **Public Art Committee Report**

- Commissioner Gates stated passed out the sign-up sheet for the upcoming public art panels for the Commissioners to convene
- Lauren Glover discussed:
  - o Upcoming Panels: Curatorial, Art Bank (2 cohorts), Playable Art
- Commissioner Gates and Lauren Glover discussed:
  - o 3 Public Art Building Communities installations that already took place:
    - **WRAPture by Monica Jahan Bose**, occurred on May 18. WRAPture ties together the Anacostia community in Washington, D.C. and Katakhali Village in Bangladesh through fabrication and the draping of saris across five buildings in historic Anacostia.
      - 17 workshops were held in DC to create the saris
      - Multiple meetings at the Anacostia Arts Center, We Act Radio, Check It, Calvary Women's Services, Adams Morgan Community Center, Project Create, Eaton Workshop, and A/PI DVRP.
      - There were projects with homeless women at the Calvary. And women survivors of domestic violence from A/PI DVRP.
    - A Community, A Family by Candice Taylor located on the side of Justina Hair Salon on a shared parking lot at the corner of Galt Place and Minnesota Avenue, S.E.
      - The mural spurred a grant from the Seventh Ward Storefront Improvement Initiative, which resulted in the painting of the front of the two story building, and new windows.

  - FY20 Arts and Humanities Visual Arts Fellowship Program.
    - Synergy- Exhibit features works by applicants from the FY20 Arts and Humanities Visual Arts Fellowship Program. On display are pieces submitted by artists which represent their individual style and body of work.

- Commissioner Palermo asked what the grants budget would look like in FY20 and due to the new BSA Chair Kendall stated that we would have to discuss in July when more information would be available.
- Michael Bigley stated that the budget for FY20 for CAH overall was roughly \$34million but we have not gotten as far as breaking it down for the various agency functions yet but more information would be available one it's broken down.
- Heran Sereke-Brhan stated that there are a lot of new applicants come through. A lot of new faces, organizations even more individuals a lot. Some combination of our outreach and our, you know, just sort of getting the word out, is working. So, it's a good number of new people that are coming through. Also, the search for panelists is coming along great and to continue to pass along names of people in the community to participate.

  - Arts/Humanities Education Project (AHEP) Grants
    - A total of 28 applications
  - Field Trip Experiences (FTE) Grant

  - Celebrate the Creative Spark!
    - 18 arts organizations and teaching artists have been working with 23 DCPS and DCPCS schools in the fifth year of the Celebrate the Creative Spark! program.
  - Access and Inclusion Workshops- A series of workshops to share best practices in working with, and providing services to, persons with disabilities.
    - Took place on May 22<sup>nd</sup> 34 teaching artists working with facilitator, Diane Nutting to develop their skillsets for working with children with disabilities in their classrooms.
  - Teaching Artist Institute
    - Scheduled to take place at the National Building Museum on **Tuesday, August 27th and Wednesday, August 28th** and will consist of a series of panels, workshops, and networking opportunities for teaching artists to build their practical skillsets and understanding of program and assessment design, and how to be culturally competent in their work.
  - National Arts in Education Week: Professional Development Institute (PDI)
    - CAH, in collaboration with DC Arts and Humanities Education Collaborative (DCAHEC) and the arts staff of DCPS will deliver a day-long professional development institute (PDI) for classroom educators and arts specialists from DCPS and DCPCS on **Saturday, September 21, 2019.** Teachers will engage in

- David Markey discussed:
  - Five different committees together to share out on the work they've been doing. He is co-chairing the capacity building committee with Nathan Diamond, formerly of DCPS, and now at Kennedy Center.
  - Focusing on looking at what is needed by classroom teachers, art specialists in schools and teaching artists as they work with young people.
  - Equity in access committee. A fund raising committee, PR, & communications committee
  - 60 people here attended.
  - The Mayor has signed onboard. The Office of Planning, DC Public Schools, ourselves, as well as a large number of arts organizations.
