**FUNDING RECOMMENDATIONS: FY22 JURIED EXHIBITION GRANT**

**Grant Program Name:**

FY22 Juried Exhibition Grant

**Grant Program Description:**

The Juried Exhibition Grant (JEG) provides support for District-based artists to exhibit their work in a juried, themed visual art exhibition through grant support and use of CAH's exhibition space within their District owned building lobby and CAH's virtual platform.

This exhibition will be organized around the theme of environmental justice. In their work, artists may address local and/or global questions of ecology, environmentalism, biodiversity, climate change, stewardship, the relationship of climate justice to social justice, and/or other related concepts and issues.

**Number of Cycles:** 1

**Allocated Budget Amount:**

FY2022: \$ 26,000 (recommend awarding \$25,971)

**Number of Juries:** One jury

**Grant Manager:** Sarah Gordon

**Commissioner Conveners:** Maggie FitzPatrick, José Alberto Uclés

**Ranking and Award Justification:**

- **Cut-off:** All eligible applications were reviewed and scored by jurors, in an online review of portfolios, on a scale of 1-10.
  - 64 eligible applications were received. With each individual submitting up to five artworks, we received a total of 229 artworks. All were reviewed.
  - Of the 229 artworks, the recommendation is to exhibit 51 artworks by 33 applicants.
- **Allocation of Funds:** Recommend offering grants to 33 artists. With a total budget of \$26,000, each grantee will receive \$787. Three artists are new applicants to CAH. All eight wards are represented.

**Total Recommendation:**

**Grant awards of \$787 to each of the 33 recommended artist applicants, a total of \$25,971, for the exhibition of the 51 recommended artworks.**
