**Grant Program Name:**

FY22 CCP: Cooper Gordon Park Sculpture Project

**Grant Program Description:**

This is a Civic Commission Project grant and partnership with DC Commission on the Arts and Humanities (CAH), the District of Columbia Water and Sewer Authority (DC Water), and the District Department of Parks and Recreation (DPR) to seek proposals from qualified sculpture artists or sculpture artist teams for the design and fabrication of permanent exterior public artwork for Cooper-Gordon Park Public Art Project (CGP). Eligible artists can be within a 50-mile radius of the District of Columbia.

The finished artwork will be placed in the renovated Cooper-Gordon triangle park in the Shaw neighborhood of Washington, DC. One (1) award will be made under this Request for Proposals (RFP). The finished sculpture will be placed in the renovated Cooper-Gordon triangle park located at 6th Street, R Street, and Rhode Island Avenue NW in the Shaw neighborhood of Washington, DC. The park will be renovated as part of DC Water's Northeast Boundary Tunnel Project

**Grant Program Description:**

The DC Commission on the Arts and Humanities (CAH), in partnership with the DC Department of Public Works (DPW), seeks international, national, or local graffiti and aerosol mural artists and artist teams to design, create and install aerosol murals as part of the MuralsDC program. This Panel was a qualifications round to select a roster of up to 12 muralists who will be matched with up to 8 walls approved by DPW and the property owners.

The MuralsDC program now in its 15th year, was established to beautify neighborhoods and communities in the District of Columbia with artistic works to:

- Positively demonstrate the culture and techniques of graffiti art
- Promote respect for public and private property
- Heighten community awareness

## **Grant Program Name:**

FY23 Civic Commission Project – Marion Barry, Jr. Legacy Public Art Project

## **Grant Program Description:**

Civic Commission Projects are unique one-time District commissioned grant programs in partnership with District government agencies. Marion Barry, Jr. Legacy Mural is a partnership between District of Columbia Commission on the Arts and Humanities (CAH) and District of Columbia Department of General Services (DGS), in collaboration with the Marion Barry Jr. Legacy Foundation, which is a 501 (c) (3) entity serving to protect, preserve, and promote the legacy and contributions of Marion Barry, Jr.

The project includes a Marion Barry Legacy Mural, interactive kiosks and/or display cases, as well as final placement of the 8 ft. plaster model of the Mayor Marion Barry Statue in the lobby of the recently dedicated Mayor Marion S. Barry Jr. Building located at 441 4th Street, NW, Washington, DC. The project is intended to capture the salient moments in the life of the late Mayor Marion Barry, Jr. and convey the story of his contributions to the transformation of the City of Washington, DC.

This is a two-step application and selection process. **Step 1** is a qualifications round from which up to three (3) finalists will be chosen to prepare a site-specific proposal based on strength of past experience working in the required mediums. Recommended finalists will submit written proposals and will be provided an opportunity to present their design concept to the advisory panel in person. Each finalist will receive a \$2,500 honorarium to develop the proposal. **Step 2** is the evaluation of the site-specific proposal and in-person presentation by the recommended finalists. One artist/artist team will be selected to implement the design. **This recommendation is for Step 1** for three (3) finalists to prepare site-specific written proposals and receive an honorarium of \$2,500 per finalist/finalist team.
