Teaching artists from the Mid-Atlantic region are invited to apply to be a presenter at the 2022 Mid-Atlantic Teaching Artists Virtual Retreat. This event will take place via Zoom on Tuesday, August 9 and Wednesday, August 10, 2022.

Sponsored by the DC Commission on the Arts and Humanities, Delaware Division of the Arts, Maryland State Arts Council, New Jersey State Council on the Arts, New York State Council on the Arts, Pennsylvania Council on the Arts, Virginia Commission for the Arts, and West Virginia Department of Arts, Culture and History, the retreat will bring together arts education professionals from across the Mid-Atlantic region to build and strengthen a regional network of highly qualified teaching artists. Participants will have the opportunity to acquire financial tools, artistic knowledge, educational pedagogy, and self-care practices that are necessary to lead sustainable careers as entrepreneurs and creatives. Intended for teaching artists of all experience levels working in school and community settings, this retreat is designed to:

- Support teaching artists holistically, sustaining both the profession (entrepreneur) and the person (discipline expertise)
- Expand the arts education landscape to include more representation of rural, urban, suburban locations, in-school and out-of-school experiences, and diverse communities
- Support teaching artists in developing high quality arts education delivery
- Expand on the learnings of the 2018 and 2020 Mid-Atlantic Teaching Artist Retreat

- Connect teaching artists with colleagues across the Mid-Atlantic region

Submitted proposals will be reviewed by the 2022 Mid-Atlantic Teaching Artist Retreat Planning Committee, comprised of arts education program managers from the sponsoring state arts agencies. Assessment criteria for selection includes (1) alignment of session content with retreat topic(s); (2) alignment of session goals with high quality online session design; (3) experience of presenter with proposed topic(s); and (4) experience of presenter with leading virtual meetings. Accepted presenters will be provided a stipend of no less than \$450 (per presenter).

Pending acceptance, presenters will be expected to:

- Attend one individual thirty-minute technical rehearsal prior to their online presentation on Tuesday, August 2 or Wednesday, August 3 between 10:00am-2:00m ET
- Provide all presentation materials (biographies, session descriptions, PowerPoint decks, reading materials, follow-up materials, etc.) by Friday, July 15, 2022
- Agree to allow recording and archiving of live online session
