SECTION I: DESCRIPTION OF FUNDING OPPORTUNITY

The Commission on the Arts and Humanities (“CAH” or “the Agency”) seeks applications for the FY26 Arts and Humanities Education Projects (AHEP). AHEP furthers CAH’s mission by encouraging progress in the arts and humanities in the District of Columbia by supporting non-profit arts, humanities, arts education, and service organizations who significantly contribute to the District of Columbia as a world-class cultural capital. This grant opportunity has the following program goals:

- Provide access to high-quality arts and humanities experiences that work to advance student academic achievement in the District of Columbia.
- Strengthen the value of an arts and humanities education as a critical component of a student's broader education.
- Support activities that are consistent with local and national learning standards for arts and humanities education, including the current state standards in non-arts content areas, where appropriate.

AHEP is open for projects of all sizes that demonstrate District impact and engage District children, youth, and older adults (those 50 years old or older).

Grants are competitive and applications are organized for review in cohorts based on the following qualifying project categories: (1) In-School Projects; (2) Out-of-School-Time Projects; (3) Professional Development Projects; or (4) Older Adult Projects.

Grant Project Types

The AHEP grant program provides support for the following types of projects:

1. In-School Projects

Projects within the traditional school day that may include artist residencies, field trips, and arts integration opportunities. Projects shall connect to curricula standards and instructional programs occurring in the schools. Assessment and evaluation criteria should emphasize an intentional and comprehensive design.

2. Out-of-School-Time Projects

Projects during after-school, weekend, and/or summer hours. They may occur on school premises but are often facilitated by non-school arts and/or humanities providers. Priority is given to projects that engage participants multiple times throughout the year.

3. Professional Development Projects

High-quality training opportunities for educators that enhance their skills in an arts discipline or in the integration of standards-based arts and/or humanities instruction with non-arts academic content. The project shall target classroom educators, instructional staff, or teaching artists providing services at a DC public or public charter school. Applications may also include components of technological support to assist in the delivery of virtual arts and humanities experiences and for the purposes of data collection and analysis.

4. Older Adult Projects

Projects using a learning framework that is culturally relevant and experiential in design to advance the engagement of adults 50 years old or older, in the arts and humanities. Projects should take place in senior centers and/or senior residential facilities in the District. The applicant shall identify an older adult population to serve, possible partners as appropriate, and a letter of project commitment from the proposed project site.

Applicants who have applied to the FY 2026 cycle of CAH's General Operating Support (GOS) grant and plan to accept an award in that category, may only apply to the FY 2026 AHEP grant if they (a) identify as an arts education organization and (b) their project scope is completely distinct from any of the projects or programs included in their FY 2026 GOS application. Applicants who are unsure if their project may qualify for this grant program are encouraged to contact a CAH grants manager.

Grant Activities

AHEP grantees should expend funds in support of progress in arts and humanities education in the District of Columbia.

Statutory Authority

Under D.C. Code §§ 39-201 – 206, the DC Commission on the Arts and Humanities evaluates and initiates action on matters relating to the arts and humanities and encourages the development of programs that promote progress in the arts and humanities in the District of Columbia. CAH is supported by District government funds and, in part, by the National Endowment for the Arts. As such, all applicable federal and District regulations, such as OMB Circulars A-102, A-133, 2 CFR 180, 2 CFR 225, 2 CFR 220, and 2 CFR 215 govern this grant.

Funding for this award is contingent on the availability of funding to CAH. This RFA does not commit the Agency to make an award. Grant award funds shall be spent within CAH's Fiscal Year, beginning October 2025 and ending September 2026.

The Agency reserves the right to issue addenda and/or amendments subsequent to the issuance of the RFA, or to rescind the RFA.

SECTION III: ELIGIBILITY INFORMATION

A. Eligible Applicants

The list below details the minimum eligibility requirements for AHEP. All eligibility requirements shall be met upon application submission. Applicants shall:

1. Be incorporated as a nonprofit with a federally-designated tax exempt status under section 501(c)(3) of the United States Internal Revenue Service (IRS) code, as evidenced by an IRS determination letter that is dated at least one year prior to the application deadline date.
2. Be registered with, and authorized to do business in, the District.
3. Ensure that proposed planning and implementation is fully carried out in the District of Columbia.
4. Have an active Board of Directors.
5. Register and comply with the regulatory requirements of pertinent government agencies, including (but not limited to): DC Department of Consumer and Regulatory Affairs' (DCRA), DC Office of the Chief Financial Officer (OCFO), DC Department of Employment Services (DOES); and the US Internal Revenue Service (IRS).
6. Be current on all taxes and liabilities owed to the District or have an approved plan to resolve such taxes and liabilities as demonstrated by a certification of "Citywide Clean Hands" (CCH) from the District of Columbia Office of Tax and Revenue.
7. Be in good standing with CAH.
8. Have a principal business office address located in the District of Columbia, subject to an on- site visit. (Note: Applicants shall not use Post Office boxes or the address of board members or volunteers as evidence of the principal business address).

B. Inclusion, Diversity, Equity and Access (I.D.E.A.)

CAH embraces a commitment to the philosophy of Inclusion, Diversity, Equity and Access (I.D.E.A.) and complies with the Americans with Disabilities Act (ADA) (42 U.S.C. §§ 12101 et seq.) in its work. CAH encourages applicants and grantees to be as inclusive, diverse, equitable, and accessible in their work throughout the District of Columbia. Successful applications consider a broad definition of "accessibility" by addressing financial, geographic, demographic, cultural, and developmental access in their programming/projects. Please review *Addressing Inclusion, Diversity, Equity and Access (I.D.E.A.) in Grant Applications* in the Guide to Grants for full details.

C. Financial Misconduct or Fraud Disclosure

Applicants shall disclose in a sworn, written statement as to whether the applicant has been indicted or convicted of any crime or offense involving financial misconduct or fraud within the last three (3) years of the date of submitting the application. If the response is in the affirmative, the applicant shall describe the circumstances.

D. Other

There is no matching requirement or cost sharing for AHEP grants.
Applicants may submit one (1) AHEP application per fiscal year cycle.

- Recipients (or intended recipients) of a CAH FY 2026 General Operating Support (GOS) grant who do not dedicate the majority of their programming services and organizational budget to children and youth.
- Individuals.
- Arts and humanities organizations with a majority of their constituents who reside outside of the District of Columbia.
- Tax-Exempt organizations other than 501(c)(3) designated entities.
- Private clubs and organizations that prohibit membership based upon race, gender, color, religion, or any other classes identified in the District of Columbia Human Rights Act.
- Organizations that require “fiscal agents”; for-profit organizations; private foundations, political organizations; colleges; universities; foreign governments; federal government entities; and other District of Columbia government agencies, including DC Public Schools.
- Organizations submitting an application whose content is combined with the application of another organization. Proposed projects shall be “stand-alone” projects.
- Prospective applicants debarred from procurements by the federal government, the Government of the District of Columbia or any governmental entity.

SECTION IV: APPLICATION AND SUBMISSION INFORMATION

A. Address to Request Application Package

CAH utilizes the CAH to receive all AHFP grant applications. Incomplete, incorrect, or late applications may be deemed ineligible for review and funding.

B. Technical Assistance

CAH staff are available to assist grant applicants during group or individual technical assistance sessions. Applicants may also request review of draft applications during a thirty (30) minute appointment during business hours scheduled no later than seven calendar days in advance of the grant application deadline. CAH staff cannot complete applications for applicants. To schedule a meeting, applicants may contact the CAH staff listed in Section VII below. Applicants shall prepare their full draft application in the CAH along with any questions in advance of scheduling a meeting for technical assistance. For in-person workshops, photo identification is required to enter CAH offices. CAH also publishes answers to frequently asked questions to its [website](#) on a weekly basis.

C. Workshops

D. Application Forms and Content

Each application shall, where applicable:

- Provide a brief overview of the organization’s general programming but articulate the details of a unique project that is the focus of the project grant application.
- Demonstrate expertise in offering developmentally appropriate arts and/or humanities programming to students of

diverse abilities.

- Articulate an understanding of curriculum design through the provision of syllabi, lesson plans, and assessment tools.
- Develop and detail programming that provides an immersive experience for participants.
- Provide evidence of an intentional and comprehensive plan for assessment and evaluation.
- Demonstrate that all project activities occur within the District of Columbia.
- Demonstrate experience in offering high-quality, impactful professional development for educators in order to enhance their skills in an arts discipline or in the integration of standards-based arts and humanities instruction with non-arts academic content.
- Provide details on project activities, audience, and collaborators in implementing an older adult (50 years old or older) arts learning curriculum aimed at advancing creative aging in the District.

In addition to the required narrative questions within the online application, applicants shall submit additional documents with their AHEP application. Documents shall be uploaded in PDF form through the CAH Grant Application Portal prior to the application deadline. Applicants shall include at least one (1) work sample no more than three (3) years old from the date of submission. Submitting older work samples may render the application ineligible for funding consideration.
2	Support Materials	Up to three (3) additional items (e.g., letters of support, awards, programs, publicity, sample syllabi, lesson plans etc.).
3	Résumés of Key Personnel	Examples include artistic/managing/executive directors; teaching artists; etc. Provide roles, areas of responsibility, and ward or state of residence.
4	Budget Form	Detailed financial analysis of how grant funds will be spent, if awarded.

Applicants are fully responsible for the content of their application materials. An automated confirmation of an applicant’s submission does not guarantee an applicant’s eligibility (see below, “Review Process”). CAH staff cannot make corrections to applications on behalf of applicants. CAH staff review applications for completeness and contact applicants for any incomplete documents within five (5) business days of the deadline. Applicants shall update their application within five (5) business days of CAH’s notification. Failure to do so shall disqualify the application.

E. Grant Application Process

1. Read the Guide to Grants.
2. Read the RFA guidelines (for the desired grant program) and determine eligibility.
3. Go to Apply for Grants and select Grant Application Portal to register as a user. (Note: To reset a user password either select “Forgot your password?” or click here).
4. Upon registration, applicants select the desired grant program(s).
5. Complete the application questions, budget, and budget narrative data.
6. Upload required documents, supplementary material, and work samples.
7. Double-check the application for thoroughness, clarity, and typographical errors.
8. Submit the application by 10:00 PM ET on the grant program’s deadline date.
9. Ensure receipt of grant submission confirmation email, auto generated by the online portal, by the application deadline.

F. Submission Dates and Times

Complete AHEP applications shall be submitted online via the CAH Grants Application Portal by 10:00 PM EST on Tuesday, June 24, 2025. CAH does not accept mailed, emailed or hand-delivered copies of grant applications or required attachments. Technical issues or failure to receive a confirmation email should be immediately brought to the attention of the CAH staff listed in Section VII below. Incomplete, incorrect, or late applications are deemed ineligible for review and funding.

CAH accepts reasonable accommodation requests from applicants with disabilities. To request a reasonable accommodation for application submission, contact Jenna Kriegel, Arts Grants Coordinator at CAHaccessibility@dc.gov and await request approval. Reasonable accommodation requests shall be made no later than seven (7) calendar days before the AHEP application deadline.

G. Funding Restrictions

As a District of Columbia agency, CAH shall ensure that all award funds are expended in a fiscally responsible manner; all awarded funds are subject to audit and Performance Monitoring. Allowable costs are those that the District government and CAH have determined as valid expenditures. Grantees will be responsible for demonstrating expenses in Final Reports.

Examples of “Allowable Costs” Related to the Grant:
Salaries for arts and humanities professionals for nonprofit organizations.
Artists/humanities practitioners, or consultants.

Space rental and fees directly related to project implementation.
Travel and transportation directly related to project implementation.
Materials, supplies, and equipment purchases that are no more than 25% of the award and are directly related to the work of project implementation.
Overhead, maintenance, and administration not exceeding 35% of the grant award.

Examples of “Unallowable Costs” Related to the Grant:
Food and beverages.
Tuition and scholarships.
Expenses associated with an organization assuming the role of a fiscal agent for another organization.
Costs related to fundraisers and special events.
Debt reduction.
Expenses unrelated to the execution of the scope of work.
Operational reserve.
Temporary or permanent public art projects.
Re-granting (also known as “sub-granting”).
Funding to universities, foreign governments or DC government agencies, including DCPS.

AHEP grant program applicants may apply for other project-based grants in FY 2026 but if awarded multiple, they shall only accept one grant from East Arts (EA), Field Trip Experiences (FTE), Public Art Building Community (PABC), or Projects, Events, or Festivals (PEF). Note: grant recipients of an FY 2026 General Operating Support (GOS) grant are ineligible for FY 2026 PEF funding.

The grantee will be responsible for demonstrating expenses, as applicable, in Interim and/or Final Reports. Grantees with questions regarding allowable costs may contact the AHEP grant program manager.

H. Other Submission Requirements

The Agency shall not be liable for any costs incurred in the preparation of applications in response to the RFA. The applicant agrees that all costs incurred in developing the application are the applicant’s sole responsibility.

SECTION V: APPLICATION AND REVIEW INFORMATION

CAH selects individuals who are arts, humanities and/or business professionals, independent of CAH, to serve as advisory review panelists for each grant program. The role of a panelist is to review and score an eligible application’s content to the established grant program review criteria. Panelists assist in making funding recommendations to the Commission, and are arts, humanities and/or business professionals, independent of CAH. CAH advises panelists to remain impartial in their review of CAH grant applications, and it ensures that its panelists recuse themselves from review of any application that presents, or appears to present, a personal or professional conflict of interest.

A. Review and Selection Process

The Agency reserves the right to accept or deny any or all applications if the Agency determines it is in the best interest of the Agency to do so. The Agency shall notify the applicant if it rejects that applicant’s proposal. The Agency may suspend or terminate an outstanding RFA pursuant to its own grantmaking rules or any applicable federal regulation or requirement. The Agency may conduct pre-award on-site visits to verify information submitted in the application and to determine if the applicant’s facilities are appropriate for the services intended. If there are any conflicts between the terms and conditions of the RFA and any applicable federal or local law or regulation, or any ambiguity related thereto, then the provisions of the applicable law or regulation shall control, and it shall be the responsibility of the applicant to ensure compliance.

SECTION VI: AWARD ADMINISTRATION INFORMATION

A. Award Notices, Anticipated Announcement and Award Dates

CAH will notify applicants of the results of their application and the applicable award disbursement process on or shortly after October 1, 2025, via (1) a letter of intention to award or (2) a letter of denial. These notifications will be sent via the applicant's email as it appears in the CAH Grants Portal.

For award recipients, the date of CAH grant award payment disbursement(s) is subject to the availability of funds and the processing of required documentation. CAH staff will advise grant award recipients on the payment disbursement process on or after October 1, 2025. More details may be found on CAH's website at [Resources for Grant Recipients](#). CAH reserves the right to rescind any grant award for non-compliance with CAH policies, regulations, and RFA guidelines at any time. Grant recipients with unmet reporting obligations regarding any CAH funding program are ineligible to receive additional awards from CAH.

B. Programmatic, Administrative, and National Policy Requirements

Federal and District of Columbia laws require all grant applicants to comply with all applicable laws and regulations prohibiting discrimination. The list of those laws and regulations include but are not limited to: Title VI of the Civil Rights Act of 1964; Title VII of the Civil Rights Act of 1964 (P.L. 88-352); Title IX of the Education Amendments of 1972, as amended (20 U.S.C. Sections 1681-1686); Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. Section 794); the DC Human Rights Act of 1977; and the Americans with Disabilities Act of 1990 (42 U.S.C. §§ 12101 - 12213).

The AHEP grant is funded in part by the National Endowment for the Arts (NEA). Grantees who accept awards in this category shall adhere to the programmatic scope and spending requirements stipulated by the NEA. All grant recipients are subject to risk assessments and monitoring requirements. Those practices are discussed in greater detail in the applicants’ grant agreements with CAH. CAH shall monitor and evaluate all grant funded activities to assure compliance with all applicable District of Columbia’s statutes, regulations, orders and other requirements. Additionally, grantees shall include a CAH logo and a credit line in all grant-related announcements and promotional materials and publicly credit CAH’s support in all related public events.

C. Reporting

Each grantee shall submit a Final Report regarding: (1) the extent to which they advanced their artistry, humanities work, and profession throughout the fiscal year, (2) details regarding artistic and humanities-focused activities and engagement with communities within the District of Columbia, and (3) the growth that was made in advancing practices of equity with internal and external stakeholders.

Each grantee awarded more than \$12,500 shall also submit an Interim Report outlining project progress or operations expenses through the midpoint of CAH’s fiscal year, changes and/or updates to projected timelines, and an estimated count of populations served during the first half of the grant cycle.

Final Reports are due Friday, October 16, 2026. Interim Reports are due April 17, 2026. Failure to submit all required reports shall make grantees ineligible for future funding from CAH.

D. Payment

CAH has the right to withhold, reduce, or rescind a grant award according to the terms and provisions of the grant agreement or if the grantee: (1) fails to meet deadlines for grant reports; (2) refuses to provide access for monitoring; and/or, (3) fails to comply with the terms of the grant award contract requirements.

All grant recipients are responsible for reporting their respective grant award(s) as income on federal and local tax returns (in accordance with applicable law) and are strongly encouraged to consult with a tax professional and the United States Internal Revenue Service.

ADDENDUM A: WORK SAMPLES AND SUPPLEMENTARY MATERIALS

CAH values and emphasizes excellence in all grant programs within all disciplines. This section contains detailed information on the CAH’s requirements and suggestions regarding content. Arts, humanities, and arts education content and/or merit are one of several criteria on which an application is reviewed. Content and/or merit is demonstrated to the

advisory review panelists through the applicant's Work Samples, Support Materials, and Résumés of Key Personnel. Of these, the work sample carries the most weight because it shall contain the clearest depiction of the applicant's best work(s) of art and/or humanities. All applicants shall submit arts, humanities, or arts education work samples.

Section 1 - Work Samples

Work samples are critical to each application and are carefully considered during application review. CAH strongly recommends that applicants pay close attention to the content of work sample submissions. The guidelines on work sample submissions depend on the grant program. Applicants are encouraged to adhere to the suggested work samples or risk ineligibility for consideration of a grant award. Work samples shall be no more than three (3) years old from the date of submission. Submitting older work samples may render the application ineligible for funding consideration.

Section 2 - Support Materials

Support materials are documents that strengthen the application and provide additional information that directly relates to the grant request. Support materials do not take the place of a work sample. They do, however, reinforce the quality of the applicant's arts and humanities disciplines(s).

Some examples of supporting materials include:

- Theater/exhibition reviews;
- Letters of recommendation;
- Certificates of achievement or recognition;
- Sample syllabi and lesson plans;
- Assessments and evaluations;
- Awards; and/or
- Recordings of artistic process, creation or experience.

Assessment and Evaluation

Purpose:

- To determine the efficacy of a program, as articulated in the program goals and as required for grant reporting.
- To provide evidence to support changes in order to improve the program and its delivery.

Types:

- Qualitative assessment is often subjective in approach and narrative in nature.
- Qualitative assessment provides empirical data that demonstrates growth in the knowledge, understanding....

Assessment and Evaluation Design

There are many ways to assess and evaluate programming including: needs assessments; pre- and post-testing; and formative, observation, and summative assessments that utilize mixed-method approaches such as portfolio/process-folio assessments.

Section 3 – Résumés of Key Personnel

Another way panelists determine the artistic content of each application is to review the résumés of the key artists, administrators, and facilitators involved in the grant activities. Those professionals involved in the organization determine the capacity of the organization and ability for the applicant to effectively create an excellent arts and humanities product and/or experience. Their backgrounds as artists and administrators should be relevant to the organization and clearly demonstrated through their professional résumés.
