# **Art Bank Spotlight**


January is a time of reflection, renewal, and celebration.

In honor of the Lunar New Year, observed on January 22, 2023, we feature Anthony Le's Oh Brother (2020).

A first-generation Vietnamese American artist, Le investigates questions about the Asian American experience, sometimes returning to his own childhood memories. Here, the young Le and his brother hold a bunch of small bananas representative of their Southeast Asian heritage. Though challenging his sense of identity as a child, Le has come to realize that these symbols of difference represent power and distinction.

Born in Chattanooga, TN, Anthony Le is a self-taught artist residing in Washington, DC. He is a co-founder of the Model Mutiny Art Collective with his artist spouse Ashley Jaye Williams.

GOS application for FY24 (Oct 1, 2023 to Sept 30, 2024) opens Mon, Jan 23rd.

Please note: If your organization has received at least one of the following in FY2022 or FY2023 you may be eligible for GOS:

- Arts and Humanities Education Project
- East Arts
- Facilities and Buildings
- Field Trip Experiences
- Projects, Events, or Festivals
- Public Art Building Communities

Additional eligibility requirements will be detailed in the RFA once open. Additional FY24 Grant Program opportunities will be released in mid to late Spring.



# **Non-CAH Funding Opportunities**

## **NEA 2023 Grant Opportunities Now Available**

The National Endowment for the Arts (NEA) announced in December that grant guidelines and application materials are now available for Challenge America and Grants for Arts Projects (GAP). These grants to organizations support specific projects in any part of the nation's 50 states, the District of Columbia, and U.S. jurisdictions.

The Challenge America application deadline is April 27, 2023 for projects taking place beginning in 2024. The Grants for Arts Projects application Deadlines are February 9 and July 6, 2023 for projects taking place beginning in 2024.

# DCEFF Vantage Grant for Emerging BIPOC Filmmakers

The Environmental Film Festival in the Nation's Capital (DCEFF) is committed to expanding the storytelling pipeline, amplifying the voices and supporting the work of emerging BIPOC filmmakers with a commitment grant. The \$12,500 DCEFF Vantage Grant will be bestowed to an emerging BIPOC filmmaker, working on a short film or their first feature, addressing a timely environmental issue at any stage of pre-production through post-production. The grant will be the culminating award given to a winning pitch, presented live at the 31st Annual DCEFF on March 26, 2023
