

#### CAH EXECUTIVE DIRECTOR



Heran Sereke-Brhan has spent over two decades studying and conducting research on African histories and cultures. She grew up enjoying music and theatre performances in Addis Ababa, Ethiopia, where many of the artists were family members or friends. She understood early on the power of the arts to nurture the imagination and create community. To honor their lives and contributions, Heran later helped stage performances and compile and edit works of notable Ethiopian writers and playwrights.

Heran joined the Commission on the Arts and Humanities (CAH) as Senior Grants Officer in July 2017. Prior to joining CAH, she served as Deputy Director for the DC Mayor's Office on African Affairs. She has worked at such cultural and educational institutions as the School for International Training's Study Abroad Program, the Harn Museum at the University of Florida, Addis Ababa University, and the Smithsonian's National Museum of African Art.

Heran holds a PhD in History with minors in African American and Caribbean History and African Art History from Michigan State University.

#### GRANTMAKING

- Awarded 998 grants to individuals and organizations in all 8 wards
- Total funding: \$28,829,890
- FY20: 1,040 grants; \$27,135,971





#### **GRANTMAKING & COVID-19**

- 346 relief grants to individuals and organizations
- CAH Relief and Recovery grant provided \$5,500 for individuals. Funded 94% of applicants (266 individuals) for a total of \$1.4m
- FAB-Relief grant program awarded 80 organizations funding to pay rent/mortgage for a total of \$1.8m





#### **GRANTMAKING & COVID-19**

- FY21 Organizational enhancements for 199 organizations for a total of \$4.1m
- Over \$7.3m in relief funds disbursed to DC's arts & cultural sector in FY21





#### INCLUSION, DIVERSITY, EQUITY, ACCESS

- December 2020, CAH Task Force on Equity, Inclusion, & Belonging delivers its final report with recommendations to the Board of Commissioners
- 18 of the 44 recommendations already implemented or in progress





#### INCLUSION, DIVERSITY, EQUITY, ACCESS

- FY22 General Operating Support grant: weighted review criteria on IDEA ranging in weight from 15-40%
- Grant windows open for up to seven weeks, extended till after work hours. Additional (new) workshops after award notifications and before payment process
- Collection of demographic data on panelists and grant applicants





#### **COMMUNITY ENGAGEMENT**

- January May 2021, online community engagement agency-wide
  - Tele-Townhalls: 2
  - Business of the Arts: 8
  - Artists Showcase: 4
  - CAH in the Community: 6
- Total attendance: 2,107 (less than 5 months)

- Increased access to Commission meetings by livestreaming to YouTube
- New agency website user-friendly design, with more updates to come
- New CAH Strategic Plan & Public Art Master Plan Update

**Reggie Van Lee** is Partner and Chief Transformation Officer at the Carlyle Group, helping ensure that the firm is maximizing its market competitiveness, driving growth and operating most effectively and efficiently as an institution.

He also serves as the Chair of the Washington DC Commission on the Arts and Humanities, appointed by Mayor Muriel Bowser. Formerly, he served as Chair of the board of Washington Performing Arts and Vice Chair of the board of the Washington Ballet. He was named one of the top 25 consultants in the world by Consulting Magazine, selected as a Washington Minority Business Leader by the Washington Business Journal and named Black Engineer of the Year by Black Engineer magazine. He holds both a Bachelor of Science and a Master of Science in Civil Engineering from MIT and an MBA from Harvard University.
